

# **Notice to Members: Appointment of Club Directors**

The NSW club industry is currently facing a perfect storm of challenges that demand innovative and strategic leadership. This situation is further complicated by negative media coverage surrounding gaming activities, and the increasing pressure on the clubs and directors personally, to ensure they are addressing the issue of gambling harm. In light of these factors, clubs must not only focus on operational efficiency but also on building a positive community image.

To successfully navigate this tumultuous environment, the need for a highly skilled and diverse board is paramount. A board that brings a variety of perspectives and expertise can better anticipate market trends, regulatory shifts, and community sentiment. Diverse leadership can foster innovative thinking and creative problem-solving, enabling clubs to respond proactively to challenges rather than reactively. Furthermore, a board equipped with various and diverse skills such as governance; knowledge of state and government legislation, in particular the Corporations Act and Registered Clubs Act; accounting; strategic planning; legal and contract knowledge; community engagement; government relations and processes and risk management (to name a few) can develop comprehensive strategies that not only address current challenges, but also position the club for sustainable growth in the future. In essence, the composition of the board is crucial in steering clubs through these complex dynamics, ensuring they remain resilient and competitive in an ever-evolving industry landscape.

The Board of Oak Flats Bowling and Recreation Club Limited have been navigating the need to ensure club facilities are maintained and upgraded, diversifying income streams given the recent and future changes to gaming legislation, whilst simultaneously reviewing past accounting practices, upgrading flawed and outdated finance and other systems. This notice serves to advise members that the Board of Directors of Oak Flats Bowling and Recreation Club Limited has resolved to appoint two Director's to the Board, as authorised by the:

### **REGISTERED CLUBS REGULATION 2015 - REG 31**

Appointments made by governing body.

The legislation notes:

- (1) The elected members of the governing body of a registered club may appoint up to two persons as members of the governing body.
- (2) A person appointed under subclause (1):
- (a) may be appointed for a term of no more than 3 years, and
- (b) must be an ordinary member of the club at the time of, and for the duration of, his or her appointment, and
- (c) is not eligible for re-appointment under subclause (1), including reappointment after the end of that term.
- (3) Within 21 days of an appointment being made under subclause (1), a notice must be clearly displayed on a notice board on the premises of the registered club and on the club's website (if any) that states:
- (a) the reasons for the person's appointment, and
- (b) the person's relevant skills and qualifications, and
- (c) any payments to be made to the person in connection with his or her appointment.
